# Learning Activity

#### Clinical Scenario 1

You are a nurse in an outpatient department and you receive 35-year old Ben with unresolved back pain.

You have two (2) minutes to read the scenario. You will have seven (7) minutes to:

• Obtain a brief, focused and relevant history

- Address client concern
- Conduct a physical assessment as needed

### **Clinical Scenario 2**

Mr. Sam is a 55-year-old gentleman referred to your care by his family physician for diabetes education. He appears anxious and is dizzy.

- Address client concern
- Conduct a physical assessment as needed
